Subject: Revalidation/Authorization for carrying over balance of GIA to Government of Himachal Pradesh for running up of SRCW and allowing incurring of expenditure on the scheme during FY 2016-17.

Sir,

2. In continuation of this office earlier sanction order No. 1-10/2013-NMEW/134 dated 30/12-2016 for the Financial Year 2015-16, I am directed to convey the authorization by the Competent Authority for carryover unspent balance of Rs. 29,00,000/- to Govt. of Himachal Pradesh for running up cost of SRCW under NMEW for FY 2016-17, subject to the following conditions:-

- a) The Grant-in-Aid is towards recurring and non-recurring expenditure for running cost of SRCW in the State on the SRCW Scheme during Financial Year 2016-17.
- b) The norms and guidelines already communicated by NRCW/NMEW and conditions contained in the Sanction Order may be adhered to.
- c) The payment already released will be subject to final adjustment in the light of the audited figure of admissible expenditure up to FY 2016-17.
- d) It may be noted that the funds, if remain unspent at the end of this Current Financial Year that is as on 31/03/2017, the same cannot be utilized without the prior concurrence/re-validation by this Ministry.**

3. Himachal Pradesh being a Special Category State, NMEW schemes shall be implemented on a sharing ratio of 90:10 between Central Govt. and State Govt. respectively.

4. The annual budget towards running cost of SRCW is Rs. 38,00,000/- of which Rs. 34,20,000/- and Rs. 3,80,000/- is to be borne by Central Govt. and State Govt. in the ratio of 90:10 respectively.

5. It may also be noted that next instalment of GIA under this Scheme shall be released only after proper Utilization Certificate along with Statement of Expenditure (SOE) with details for the relevant Financial Year is furnished.
