SANCTION ORDER CUM LETTER OF AUTHORITY

Subject:- Authorization of Grant-in-aid to UT of Chandigarh Administration for running up of State Resource Centre for Women (SRCW) under National Mission for Empowerment of Women (NMEW) for FY 2016-17.

Sir/ Madam,

I am directed to convey the sanction of competent authority to authorize GIA of **Rs. 16,50,000/- (Rupees sixteen lakh fifty thousand only)** to UT of Chandigarh Administration for running up of State Resource Centre for Women (SRCW) under National Mission for Empowerment of Women (NMEW) for FY 2016-17, subject to the following conditions:-

- (i) That the funds sanctioned shall be utilized for the purpose for which it is sanctioned. A separate account in respect of the sanctioned amount is to be maintained.
- (ii) The accounts of the SRCW/State Govt. shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under provision of CAG (DPC) Act, 1971 and internal audit by the Principal Accounts Officer of the Ministry or Department whenever the Institution or Organization is called upon to do so.
- (iii) The Grant-in-Aid is towards the recurring, non-recurring and Mission activities expenditure for running up of SRCW/PSK/VCFS under National Mission for Empowerment of Women as per approved pattern.
- (iv) The Grant-in-Aid released through this sanction order would cover liabilities/expenditure of SRCW/PSK/VCFS covering the period **up to 31/03/2017 only**. It may be noted that the funds, if remain unspent at the end of this Financial Year, the same cannot be utilized without the prior concurrence by this Ministry beyond 31/03/2017.
- (v) The Institution/Organisation shall maintain a record of all assets acquired wholly or substantially out of Government such assets not be disposed of encumbered or utilized for purpose other than those for which grants were given without prior sanction of the Government of India, should the institution/organization ceases to exist at any time, such properties will revert to the Government of India or disposed of in accordance with the orders may be given by the Government of India.

2. Expenditure for State Resource Centre for Women shall be incurred as per above conditions and the revised instructions issued by this office/Ministry from time to time.
3. State Govt(s)/UT Admn. will submit the Utilization Certificate (UC) in GFR form 19A along with item-wise Statement of Expenditure (SOE) for PSK/SRCW project duly signed by the authorized State Govt. officer. The State Govt. shall also submit quarterly Progress Report on the Project as well as Demand for Funds on the SOE Performa before claiming next installment of GIA duly signed by the authorized State Govt. officer.
4. The amount sanctioned herein may be drawn in accordance with the instructions contained in the Pay & Accounts Office, Ministry of Welfare letter No.G-27017/80- P/ PA/Grants-in-aid circulars dated 24.11.1981, as amended from time to time, i.e. the Union Territory Administrations of Chandigarh will draw the amount from the local treasury and then send the vouchers to their Accountant General Pay & Accounts Offices for getting reimbursement as per the procedure laid down in those instruction and also in accordance with the instructions contained in the erstwhile Ministry of Social and Women's Welfare letter No.G-27-17/ 82-85/Grants-in-aid circular dated 23.11.1984.
5. The expenditure involved is debitible to Demand No. 97, Major Head No. 2235 - Social Security and Welfare, 02- Social Welfare, 103 – Women's Welfare, 70- National Mission for Empowerment of Women including IGMSY, Detailed Head 01- National Mission for Empowerment of Women (NMEW), Object Head 70.01.31 –Grant-In-Aid -General (Plan) for the current financial year 2016-17.
